AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF FAIRVIEW PARK HOMES - OPEL (1-STOREY TOWNHOUSES: ECONOMIC HOUSING PROJECT) WITH 11-LOTS, CONTAINING AN AREA OF SEVEN HUNDRED TWENTY-NINE (729) SQ. MTS., COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 32246 OF THE REGISTRY OF DEEDS OF QUEZON CITY, AND LOCATED AT LOT 21, BLOCK 42 (LRC) PCS-8142, OPEL ST., FAIRVIEW PARK SUBDIVISION, BARANGAY FAIRVIEW, QUEZON CITY, METRO MANILA, OWNED BY THE GOVERNMENT SERVICE INSURANCE SYSTEM, AS APPLIED FOR BY THE COLLECTIVE PROJECT MANAGEMENT, INC., WITH OFFICE ADDRESS AT THE 5/F EVEKAL BLDG., NO. 855 ARNAIZ AVENUE, LEGASPI VILLAGE, MAKATI CITY, METRO MANILA, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of FAIRVIEW PARK HOMES - OPEL (1-Storey Townhouse: Economic Housing Project) with 11-lots, containing an area of Seven Hundred Twenty-Nine (729) sq. mts., covered by Transfer Certificate of Title Numbered 32246 of the Registry of Deeds of Quezon City, and located at Lot 21, Block 42 (LRC) Pcs-8142, Opel St., Fairview Park Subdivision, Barangay Fairview, Quezon City, Metro Manila, owned by the GOVERNMENT SERVICE INSURANCE SYSTEM, as applied for by the COLLECTIVE PROJECT MANAGEMENT, INC., with office address at the 5/F Evekal Bldg., No. 855 Arnaiz Avenue, Legaspi Village, Makati City, Metro Manila, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220, details of which are as follows:
