ORDINANCE NO. SP- 1007, S-2001

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF FERNDALE HOMES PHASE 4, (A RESIDENTIAL PROJECT WITH TWO HUNDRED TWENTY-TWO (222) LOTS), CONTAINING AN AGGREGATE AREA OF EIGHTY-EIGHT THOUSAND ONE HUNDRED TWENTY-SIX (88,126) SQUARE METERS, COVERED BY TRANSFER CERTIFICATES OF TITLE ISSUED BY THE REGISTRY OF DEEDS OF QUEZON CITY, OWNED BY AYALA LAND, INC., AND LOCATED AT SAMPAGUITA AVENUE, BARANGAY PASONG TAMO, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE OWNER, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND PD 957.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of FERNDALE HOMES Phase 4, (a residential project with two hundred twenty-two (222) lots), containing an aggregate area of eighty-eight thousand one hundred twenty-six (88,126) square meters, covered by Transfer Certificates of Title hereunder enumerated, issued by the Registry of Deeds of Quezon City, owned by Ayala Land, Inc., and located at Sampaguita Avenue, Barangay Pasong Tamo, Quezon City, Metro Manila, as applied for by the owner, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and PD 957, details of which are as follows:
