ORDINANCE NO. SP- 1042, S-2001

AN ORDINANCE AMENDING ORDINANCE NO. SP-583, S-97, ENTITLED: "AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF RESIDENTIAL SUBDIVISION, LOT 5 MADRIGAL ESTATE, SITUATED AT LOT 5, CAPILIAN ST., BRGY. SAN ANTONIO, QUEZON CITY, AS APPLIED FOR BY THE MEMORANDUM OF AGREEMENT BETWEEN THE QUEZON CITY GOVERNMENT AND NAGKAKAISANG MARALITANG MAMAMAYAN NG LOT 5 (NAMMA LOT 5) INC., SUBJECT TO COMPLIANCE WITH THE CONDITIONS PRESCRIBED UNDER ORDINANCE NO. SP-56, S-93, AND BP. BLG. 220."

WHEREAS, Ordinance No. SP-404, S-96, is an Ordinance Approving the Subdivision Plan of a Residential Subdivision, Lot 5 Madrigal Estate at lot 5, Capilian St., Brgy. San Antonio, Quezon City as applied for by the Memorandum of Agreement between the Quezon City government and Nagkakaisang Maralitang Mamamayan ng Lot 5 (NAMMA LOT 5) INC.;

WHEREAS, pursuant to section 458 (a) (2) (x) of Republic Act 7160, local government units, through their respective sanggunians, are authorized to process and approve subdivision plans, subject to applicable laws, rules and regulations, on the matter;

WHEREAS, there was discovered a typographical error committed in the preparation of Ordinance No SP-404, S-96, entitled, " An Ordinance Approving the Subdivision Plan of a Residential Subdivision of Lot 5, Capilian St., Brgy. San Antonio, Quezon City as amended by Ordinance No. SP- 583, S-97;"
