## ORDINANCE NO SP. 1431, S-2004

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED RESIDENTIAL HOUSING PROJECT (MODEL E - BP 220) WITH THIRTY-FIVE (35) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF TWO THOUSAND (2,000) SQUARE METERS, COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED RT-89913 (95507) TO RT-89919 (95513) OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT LOT 102-J-1 TO J-7, (LRC), PSD-46545, BROOKSIDE, BARANGAY BAGONG SILANGAN DISTRICT II, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY KAPATIRANG SAN JOSE ASSOCIATION, INC. (LOT 102-J), FERNANDEZ - PROPERTY, REPRESENTED BY ITS PRESIDENT, MS. ELEMIA E. UNTALAN, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED

SECTION 1. The subdivision plan of a Socialized Residential Housing Project (Model E - BP Blg. 220) with Thirty-Five (35) lots: Community Mortgage Program, containing an area of Two Thousand (2,000) square meters, covered by Transfer Certificates of Title Numbered RT-89913 (95507) to RT-89919 (95513) of the Registry of Deeds of Quezon City, located at Lot 102-J-1 to J-7, (LRC), PSD-46545, Brookside, Barangay Bagong Silangan, District II, Quezon City, Metro Manila, as applied for by Kapatirang San Jose Association, Inc. (Lot 102-J), Fernandez. Property, represented by its President, Ms. Elemia E. Untalan, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Fig. 220, details of which are as follows:
