AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED RESIDENTIAL HOUSING PROJECT (MODEL E - BP 220) WITH TWO HUNDRED FOUR (204) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF TEN THOUSAND EIGHT HUNDRED THIRTY-THREE (10,833) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED RT-42149 (361015) OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT LOT 804 - NEW-A-2-A, (LRC), PSD-339563, DALTON AND ODONELL STREETS, BARANGAY HOLY SPIRIT, DISTRICT II, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE HOLY SPIRIT BETTER VILLE HOMEOWNERS ASSOCIATION, INC.
