ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED RESIDENTIAL HOUSING PROJECT (MODEL E - BP 220) TWO HUNDRED SEVENTEEN (217) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF FOURTEEN THOUSAND FIFTEEN (14,015) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED N-235658 OF THE REGISTRY OF DEEDS OF QUEZON CITY, AND LOCATED AT LOT 50-C-1-F, (LRA) PSD-372437, GOLDEN SHOWER STREET, GROUP 1, AREA B, BARANGAY PAYATAS, DISTRICT II, QUEZON CITY, METRO MANILA. AS APPLIED FOR BY THE GOLDEN HOMEOWNERS ASSOCIATION, INC., PHASE II (THE MANILA REMNANT CO., INC. PROPERTY), REPRESENTED BY ITS PRESIDENT, NICANOR R.
