ORDINANCE NO. SP- **1493**, S-2005

AN ORDINANCE REQUIRING ALL DRIVERS OF PASSENGER JEEPNEYS, MOTORIZED TRICYCLES AND PEDICABS FOR HIRE PLYING WITHIN THE TERRITORIAL BOUNDARIES OF QUEZON CITY TO SECURE AND DISPLAY AT ALL TIMES A DRIVER'S IDENTIFICATION CARD AND IMPOSING PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES.

WHEREAS, the City Council, in the interest of public order and safety, had enacted several Ordinances providing a system to regulate the registration and operation of public utility vehicles plying within the territorial boundaries of Quezon City;

WHEREAS, said Ordinances remain to be in full force and effect, and have resulted in better supervision over the operators/owners of passenger jeepneys, motorized tricycles and pedicabs for hire;

WHEREAS, there is a need to adopt uniform and effective system for the registration, regulation and identification of all drivers of passenger jeepneys, motorized tricycles and pedicabs for hire;

WHEREAS, this Ordinance will best serve the interest of the passengers in order to easily identify the drivers of jeepneys, motorized tricycles and pedicabs for hire specially in cases of vehicular accidents which they may be encountered.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. All drivers of passenger jeepneys, motorized tricycles and pedicabs for hire plying within the territorial boundaries of Quezon City are required to post their Driver's Identification Card with 2 x 2 picture at the front portion of the windshield of their vehicles. Said identification card shall contain the name of the driver, the driver's license number and his residential address.


SECTION 2. The Barangay Operations Center (BOC) shall start to receive application for Driver's Identification Card one (1) month after approval of this Ordinance and every two (2) years thereafter for purposes of renewal.

Officers of different public utility drivers and/or operators association are encouraged to closely coordinate and render assistance to their members for prompt and efficacious implementation of this ordinance.

SECTION 3. Only Filipino citizens not younger than eighteen (18) years of age duly licensed to operate motor vehicles and/or those certified by the owners of pedicabs shall be issued Driver's Identification Card pursuant to this Ordinance.

SECTION 4. All applicants for Driver's Identification Card shall submit the following documents:

- a. Certification of the owner-operator in favor of the applicant as authorized to drive the PUJ or Tricycle of Pedicab.
- b. Clearance from the Office of the Barangay Captain with jurisdiction over his residential address.
- c. Copy of the Driver's License issued by the Land Transportation Office (LTO).

SECTION 5. Any driver of the above-named public utility vehicles found violating the provisions of this Ordinance shall be punished by a fine of not less than Five Hundred Pesos (P500.00) or imprisonment of not more than six (6) months or both at the discretion of the court.


SECTION 6. The Tricycle Regulatory Unit (TRU) and the Department of Public Order and Safety (DPOS) shall coordinate to set up the guidelines for the strict implementation of this Ordinance upon its approval.

SECTION 7. This Ordinance shall take effect after publication on a newspaper of general circulation.


