ORDINANCE NO. SP-1535, S-2005

AN ORDINANCE PROHIBITING MEMBERS OF THE PHILIPPINE POLICE NATIONAL AND OTHER LAW ENFORCEMENT AGENCIES OUTSIDE OF OUEZON CITY POLICE STATION FROM CHECKING, INSPECTING OR RAIDING ESTABLISHMENTS WITHIN THE TERRITORIAL JURISDICTION **OUEZON** CITY WITHOUT PRIOR AND PROPER COORDINATION WITH THE LOCAL POLICE STATION AND PROVIDING PENALTY FOR VIOLATION THEREOF.

WHEREAS, there are some members of the Philippine National Police (PNP) and other law enforcement agencies not stationed in Quezon City who are harassing business establishments in the city under the pretense of inspecting their business licenses, permits and alleged unlawful activities to extort money;

WHEREAS, any inspection or checking activities to be conducted by any group of law enforcement agencies should first be properly coordinated with the local police station to avoid misencounter between the same police authorities concerned;

WHEREAS, any checking or inspecting of business establishments like night clubs, karaoke bars and other similar establishments should be accompanied by the necessary mission order issued by a higher rank police authority to be presented to the Chief of Police of Quezon City for proper coordination and the immediate submission of an after mission report to the City Mayor, and the City Council for legislation purposes.

## NOW, THEREFORE.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED;

SECTION 1. Any member/s of the Philippine National Police (PNP) and other Law Enforcement Agencies not stationed in Quezon City are heretofore prohibited from inspecting business establishments for business license and permits, health certificates, building and engineering permits within the territorial jurisdiction of Quezon City unless accompanied by the necessary mission order issued by a higher ranking police authority and properly coordinated with the Chief of Police of Quezon City.

SECTION 2. Any member of the PNP and other Law Enforcement Agencies found violating the provisions of this Ordinance shall suffer the penalty of paying a fine of Five Thousand Pesos (P5,000.00) and imprisonment of one (1) year.

SECTION 3. If any provision of this Ordinance is declared void or similar to other Ordinances, the remaining portions or provisions hereof shall not be affected and shall remain to be valid.

SECTION 4. All existing City Ordinances, Orders and Resolutions inconsistent with the provisions of this Ordinance are hereby repealed and modified accordingly.
