AN ORDINANCE APPROVING THE ALTERATION OF THE SUBDIVISION PLAN OF SPRING COUNTRY 1 & 1A (FORMERLY FINHEIGHTS III SUBDIVISION), HAVING AN AFFECTED AREA OF 12,824.00 SQUARE METERS AND AFFECTED SALEABLE LOTS FROM 35 TO 42 (INCREASED OF 7 LOTS) LOCATED AT BARANGAY BAGONG SILANGAN, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE FILINVEST LAND INC., REPRESENTED BY ENGR. ANTONIO E. CENON, FIRST VICE PRESIDENT, WITH OFFICE ADDRESS AT 173 P. GOMEZ STREET, SAN JUAN, METRO MANILA, IN COMPLIANCE PURSUANT TO QUEZON CITY ORDINANCE NO. SP-56, S-93 AND PD 957, AS PER PLANS SUBMITTED.
