ORDINANCE NO. SP- 1587 _, S-2005 (PO2005-30)

AN ORDINANCE REQUIRING ALL BUSINESS ESTABLISHMENTS AND CONSTRUCTION SITES IN QUEZON CITY TO BE FREE FROM PEST AND INSECT INHABITANTS THAT MAY CAUSE PLAGUES AND VIRUSES THAT AGGRAVATE THE HEALTH PROBLEMS OF THE CITY RESIDENTS.

WHEREAS, the alarming increase on health problems among the City's constituents are attributed to common presence of pests and insects which are the transmitter/carrier of plagues and viruses;

WHEREAS, these transmitter/carrier of plagues and viruses are rampant in most of the business establishments and construction sites operating in the City and therefore commanding the need to keep these areas clean and free from plagues and viruses;

WHEREAS, the City Council deems it necessary and wise to require all private and public business establishments and construction sites to adopt measures that shall ensure that respective premises of the mentioned areas free from pest and insect inhabitants.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. All private or public business establishments and construction sites operating in the City are to adopt measures that shall ensure its respective premises/areas free from pest and insect inhabitants that are endangering the health and safety of the public.

SECTION 2. The administration and supervision of this ordinance is vested in the City Health Department and authorized personnel of the said office shall be authorized to enter the building and/or construction sites concerned at all reasonable times to inspect and determine the compliance to this ordinance.

SECTION 3. The owner/operator of all these business establishment and construction sites who shall fail to comply with this ordinance shall suffer the fine of Five Thousand Pesos (P5,000.00).

SECTION 4. This ordinance shall take effect upon passage and approval of the City Council and approval by the City Mayor and its publication in a newspaper of general circulation in the City.
