AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF TREVISO A SINGLE DETACHED RESIDENTIAL SUBDIVISION WITH TWO HUNDRED EIGHTEEN (218) LOTS CONTAINING AN AREA OF SEVENTY NINE THOUSAND SIX HUNDRED SEVENTY FOUR (79,674.00) SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NO. N-277143 & N-277144 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF FILINVEST LAND, INC., LOCATED AT LOT 109 & 110, PSU-24733, BARANGAY BATASAN HILLS, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY ENGR. ANTONIO E. CENON, FIRST VICE PRESIDENT, FILINVEST LAND INC., WITH OFFICE ADDRESS AT 173 P. GOMEZ STREET, SAN JUAN, METRO MANILA, IN COMPLIANCE WITH THE MINIMUM REQUIREMENTS OF THE IMPLEMENTING STANDARDS, RULES AND REGULATIONS OF QUEZON CITY ORDINANCE NO.
