AN ORDINANCE AMENDING CITY ORDINANCE NO. 3433, S-57, IN ORDER TO INCREASE THE PENALTY FOR VANDALISM AND/OR DEFACEMENT OF WALLS, FENCES AND/OR OTHER SURFACE.

WHEREAS, property owners spent time, money and effort to clean and/or paint walls and fences;

WHEREAS, barangays often embarked on a cleanliness campaign including the cleaning and/or painting of walls, fences and other surface within their respective jurisdiction;

WHEREAS, efforts undertaken by property owners and the community in cleaning and painting walls, fences and other surface are often put to waste due to vandalism and defacement;

WHEREAS, there is a need to impose stiffer penalty for defacement and vandalism of walls and fences in order to encourage property owners and the barangays to clean and paint walls, fences and other surface.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Section 2 of City Ordinance No. 3433, S-57 is hereby amended to read, as follows:

"Section 2. For violation of this Ordinance, the offender shall be punished by imprisonment of not less than three (3) months nor more than six (6) months or a fine of not less than One Thousand Pesos (P1,000.00) nor more than Three Thousand Pesos (P3,000.00) or both such imprisonment and fine at the discretion of the Court; Provided, that the maximum penalty shall be imposed on any offender previously convicted under this Ordinance.

In addition to the penalty herein imposed, the offender shall also be liable for the expenses incurred for the restoration of the defaced and/or vandalized wall, fence and/or other surface."

SECTION 2. This Ordinance shall take effect upon its approval.
