AN ORDINANCE PROHIBITING THE DUMPING OF CARCASSES OF DEAD ANIMALS IN PUBLIC AND OPEN SPACES, PRIVATE PROPERTIES, RIVERS, CANALS, DRAINAGES AND OTHER WATERWAYS AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

WHEREAS, Section 458 paragraph (5) (xiii) of the Local Government Code of 1991 empowers the Sangguniang Panlungsod to enact ordinances and approve resolutions necessary for the health and welfare of the constituents, and shall:

"x x x prohibit littering and placing or throwing of garbage, refuse, and other filth and waste x x x:

WHEREAS, it has been observed that dead animals such as pet dogs, cats and pigs are dumped in drainages, canals, rivers and other waterways;

WHEREAS, this practice is instrumental in the spread of infectious diseases and causes pollution of our rivers and waterways.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The dumping of carcasses of dead animals such as dogs, pigs, cats, and rats, among others, in drainages, canals, rivers, and other waterways is strictly prohibited.

SECTION 2. Any person, whether natural or juridical, found violating this Ordinance shall be penalized as follows:

- a. First Offense: One Thousand Pesos (P1,000.00)
- b. Second Offense: Two Thousand Pesos (P2,000.00)
- c. Third Offense: Three Thousand Pesos (P3,000.00) and 36 hours of Community Service at his/her respective barangay.

SECTION 3. This Ordinance shall take effect upon its approval and publication in a newspaper of general circulation in Quezon City.
