AN ORDINANCE PROHIBITING OWNERS OF STORES OR RESTAURANTS WITHIN QUEZON CITY THAT OFFER A VIDEOKE MACHINE TO THEIR CUSTOMERS STRATEGICALLY PLACED OUTSIDE THEIR STORES OR RESTAURANTS FROM OPERATING BEYOND 9:00 O' CLOCK IN THE EVENING AND PROVIDING PENALTY FOR VIOLATION THEREOF.

WHEREAS, there are numerous restaurants or stores which installed videoke machines in order to entice the public to buy in their stores or eat at their restaurants;

WHEREAS, the owners tolerate such use due to the fact that the videoke machines increase their chances of earning;

WHEREAS, due to the noise that the videoke machines produce, it annoys the residents who are living within the vicinity of the said stores especially in the evening;

WHEREAS, it is the duty of the local government of Quezon City to ensure that the public welfare will be protected and their rights to a peaceful community be respected;

WHEREAS, with the passage of this Ordinance, the operation of the said videoke machines placed outside stores or restaurants will be regulated and the noise that it produces will be regulated.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. It shall be prohibited for owners of stores or restaurants which offer a videoke machine to their customers strategically placed outside the stores or restaurants to operate the said machines beyond 9:00 o' clock in the evening everyday.

SECTION 2. An owner of the store or restaurant who violates this ordinance shall be imposed a fine of Five Hundred Pesos (P500.00), for the first offense, and a fine of One Thousand Pesos (P1,000.00) for the subsequent violation thereof.

SECTION 3. This Ordinance shall take effect upon its approval.
