ORDINANCENO. SP. 1759, S-2007 (PO2006-148)

AN ORDINANCE PROHIBITING ASIAN UTILITY VEHICLES (AUV) OR ANY VEHICLE SIMILAR IN NATURE AND PUBLIC UTILITY JEEPNEYS FROM ENTERING CERTAIN SECONDARY STREETS IN BARANGAY MARILAG.

WHEREAS, unscrupulous drivers of certain public utility vehicles, specifically Asian Utility Vehicles (AUV), have been intruding slim and narrow secondary streets of greater Project 4, thereby endangering the safety of the residents, aside from causing immense traffic within those areas;

WHEREAS, the State, through its local government units, have the right and the obligation to curb certain practices which tend to endanger the safety of the public, as well as to provide measures and ordinances aimed at ensuring the safety and welfare of their respective constituents;

Whereas, Section 94, Article XVII of the Quezon City Traffic Management Code provides that public utility vehicles, including mega-taxis and shuttle vans with valid authorization from the Land Transportation Franchising and Regulatory Board and whose routes terminate or originate within the City, shall furnish the Traffic and Parking Management Office a copy of their approved routes.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. It is hereby prohibited for Asian Utility Vehicles (AUV) and public utility jeepneys or any vehicle similar in nature to deviate from their proper routes and, thereafter enter certain secondary streets of Greater Project 4, so as to protect the safety and welfare of the residents in the area.

The aforesaid public utility vehicles are proscribed from entering the following routes:

- 1. Legaspi corner Tuazon
- 2. Magat Salamat corner Lakandula
- 3. Aguinaldo comer F. Castillo
- 4. A. Luna corner Lakandula
- 5. Novales comer Lakandula
- 6. P. Ladia corner Novales
- 7. Camerino corner F. Castillo
- 8. J.P. Rizal corner Aurora Boulevard

SECTION 2. Any person violating any provision of this city ordinance shall be issued an Ordinance Violation Receipt (OVR) by the Traffic Officer concerned or by a duly deputized traffic enforcement officer who shall demand the presentation of the driver's license and/or the registration certificate of the motor vehicle. The apprehending officer shall then indicate the name and address of the driver, the license number and the is suing agency of the driver's license in the citation ticket. The name and address of the owner and the registering agency of the vehicle, including the certificate of registration number shall likewise be indicated therein. The apprehending officer shall stipulate the specific violation and furnish a copy of the citation ticket to the person apprehended which shall serve as a Temporary Driver's License for five (5) days from the date of issuance in accordance to Section 124, Article XXII of the Traffic Management Code of Quezon City.

SECTION 3. NO ENTRY" signs shall be posted/deployed along the intersections of the aforementioned streets to afford drivers sufficient notice of such restriction.

SECTION 4. If for any reason, any part or provision of this Ordinance shall be held unconstitutional, other parts or provisions hereof, which are not affected thereby, shall continue to be in full force and effect.

SECTION 5. This Ordinance shall take effect upon its approval.
