
AN ORDINANCE GRANTING ONE THOUSAND PESOS (P1,000.00) QUARTERLY RICE ASSISTANCE TO QUEZON CITY GOVERNMENT REGULAR EMPLOYEES STARTING BY THE YEAR 2010 AND EVERY YEAR THEREAFTER AND APPROPRIATING THE NECESSARY FUNDS THEREFOR.

WHEREAS, there is a need to uplift the welfare and living standards of the Quezon City government's own regular workforce who collectively dedicate their time and effort in performing their assigned tasks relative to the prompt delivery of basic services to the City's constituents;

WHEREAS, by virtue of the City Government's concern, it is incumbent upon its elective officials to give what is essential to the City's own regular employees an incentive by way of a quarterly rice assistance;

WHEREAS, the grant of the said quarterly rice assistance is in consonance with the City Government's desire to alleviate the economic plight of its own workers from the widespread crisis and prolonged high-cost of rice, the increase of basic commodities and such other financial difficulties besetting the City Government's working community brought by the sudden global and national economic slump;

WHEREAS, the sourcing of this form of assistance would come from the Personnel Service Fund or from any available funds which forms part of the City Government's 2010 Annual Budget.

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Coverage and Payment – All Quezon City Government regular employees are entitled to a One Thousand Pesos (P1,000.00) quarterly rice assistance which shall be granted to them by the end of each quarter of each year starting from the year 2010 and for every year thereafter.

SECTION 2. Appropriation – There is hereby appropriated the amount of Ten Million Pesos (10,000,000.00) or so much as may be necessary for the payment of the quarterly rice assistance which shall be taken from the Personnel Services Fund of the 2010 Annual Budget of from any available funds of the City Government.

SECTION 3. This Ordinance shall take immediately upon its approval.
