AN ORDINANCE DECLARING THE 2^M WEEK OF DECEMBER OF EVERY YEAR AS AN URBAN POOR WEEK IN RECOGNITION OF THE QUEZON CITY'S CONTINUING COMMITMENT TO ALLEVIATE THE CONDITION OF THE URBAN POOR SECTOR AND ITS PARTICIPATION IN THE DEVELOPMENT OF THE CITY.

WHEREAS, Quezon City, further, recognizes the role of independent people's organization to enable the people to pursue and protect, within the democratic framework, their legitimate and collective interests and aspirations through penceful and lawful means fin relation to Section 15, Art. XIII, 1987 Constitution);

WHEREAS, people's organization and homeowners associations of urban poor and bona fide associations of citizens with demonstrated capacity to promote the public interest and with identifiable leadership, membership, and structures (as defined in 2nd par. of Section 15, Philippine Constitution),

WHEREAS, the Quezon City reaffirms the right of the urban poor organizations to effective and reasonable participation at all levels of social, political, and economic decision-rusking. And the present Administration recommits to authentic consultation mechanism as mandated by the Constitution (Section 16, Article XIII).

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED.

SECTION 1. Declaring the 2nd week of December of every year as an Urban Poor Week in recognition of the Quezon City's continuing commitment to alleviate the conditions of the Urban Poor Sector and its participation in the development of the City.

SECTION 2. This onlinence shall take effect upon its approval.
