AN ORDINANCE AMENDING ORDINANCE NO. SP-1104, SERIES OF 2002 ENTITLED, "AN ORDINANCE ESTABLISHING THE PEDICAB REGULATORY SECTION UNDER THE TRICYCLE REGULATORY UNIT."

WHEREAS, In 2002, then Quezon City Mayor and present Speaker of the House of Representatives, Honorable Feliciano R. Belmonte, Jr. signed into law Ordinance No. SP-1104, S-2002 entitled "An Ordinance Establishing the Pedicab Section Under the Tricycle Regulatory Unit" which aimed to prevent the proliferation of un-registered non-motorized tricycles, colloquially known as "pedicab", by regulating the same, being classified as common carriers then as provided for under law, and thereby protecting the interests of the riding public;

WHEREAS, the aforementioned Ordinance, notwithstanding its noble intention to provide an inexpensive means of livelihood by operating pedicabs for hire within the territorial jurisdiction of this City, did not include a penal clause to hold liable those found to violate the provisions of the said Ordinance.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Section 8 of Ordinance No. SP-1104, S-2002 is hereby amended to read as follows:

"Section 8. PENALTY - Any violation of the provisions of this Ordinance shall be penalized, as follows:

a). For the first offense - Php1,000.00

b). For the second offense - Php3,000.00

c). For the third offense - Php5,000.00

SECTION 2. Sections 9, 10, and 11 of Ordinance No. SP-1204, S-2002 are hereby renumbered which shall now read as follows: Section 9. IMPLEMENTING GUIDELINES; Section 10. REPEAL; Section 11. EFFECTIVITY.
