ORDINANCE NO. SP- 2481 , S-2016

AN ORDINANCE PROVIDING FOR HOUSING ENHANCEMENT AS PART OF THE QUEZON CITY HOUSING PROGRAM.

WHEREAS, Section 12, Article II of the 1987 Constitution provides that, "The State recognizes the sanctity of family life and shall protect and strengthen the family as a basic autonomous social institution";

WHEREAS, Section 16 of the Local Government Code of 1991 states that, "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants";

WHEREAS, the existing Quezon City Housing Program provides for two (2) schemes: ownership and non-ownership (which in turn is a rental or usufruct); and

WHEREAS, the Housing Enhancement Program will be the third option which shall provide for housing beautification and enhancement to the residents of Quezon City. ≯ , ✓

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. There is hereby provided a new scheme of housing to be called as the "Housing Enhancement Program" as part of Quezon City Housing Program.

SECTION 2. The Housing Enhancement Program is a beautification, improvement, repair of existing houses which shall include masonry, carpentry, and painting, without prejudice to the ownership of said parcels of land or houses.

SECTION 3. Effectivity - This Ordinance shall take effect immediately upon its approval.
