ORDINANCE NO. SP- 2496 , S-2016

AN ORDINANCE REGULATING CERTAIN STREETS WITHIN THE TERRITORIAL JURISDICTION OF BARANGAY LAGING HANDA, BARANGAY SACRED HEART AND BARANGAY PALIGSAHAN, QUEZON CITY, AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

Introduced by Councilors JESUS MANUEL C. SUNTAY, RAQUEL S. MALAÑGEN and GODOFREDO T. LIBAN II.

Co-Introduced by Councilors Marvin C. Rillo, Vincent DG. Belmonte, Jessica Castelo Daza and Bayani V. Hipol.

WHEREAS, Section 458 (a) (5) (iv) and (V) of Republic Act No. 7160, otherwise known as "The Local Government Code of 1991", provides for the Powers, Duties, Functions of the Sangguniang Panlungsod among which are to;

"(v) Regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same. $x \times x$.

(vi) Regulate traffic on all streets and bridges; prohibit encroachments or obstacles thereon and, when necessary in the interest of public welfare, $x \times x^{n}$

WHEREAS, the three (3) barangays namely: Barangay Laging Handa, Barangay Sacred Heart, and Barangay Paligsahan approved a Joint Resolution No. 001, S-2015, entitled "Allowing One Way Traffic of Motor Vehicle in Certain Streets of Barangay Laging Handa, Barangay Sacred Heart and Barangay Paligsahan;

WHEREAS, the Department of Public Order and Safety (DPOS) Traffic Engineering Section Team, upon their thorough study, endorsed the approval of the said joint resolution to the city council;

WHEREAS, the proposed traffic regulation is one of the solutions to ease the traffic congestion and to maintain the smooth flow of traffic along the vicinity of the concerned barangays;

WHEREAS, it is incumbent upon the City Government to regulate the traffic situation and road conditions within its jurisdiction.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. TITLE – This Ordinance shall be known and referred to as "Traffic Scheme of Barangay Laging Handa, Barangay Paligsahan, and Barangay Sacred Heart"

SECTION 2. STREETS COVERED

- 1. The following streets are considered as one-way flow traffic street;
 - a) Sct. Castor Street (from Sct. Torillo Street towards Sct. Magbanua Street) ≯

- b) Sct. Lozano Street (from Mo. Ignacia Street towards Sct. Torillo Street
- c) Sct. Delgado Street (from Sct. Torillo Street towards Sct. Magbanua Street)
- d) Sct. De Guia Street (from 11th Jamboree Street towards Mother Ignacia Street
- e) Sct. Fuentabella Street (from Sct. Reyes Street towards 11 Jamboree Street)
- f) Sct. Fuentabella Extention (from Sct. Rallos Extention towards 11th Jamboree Street)
- g) Sct. Fernandez Street (from 11th Jamboree Street towards Mother Ignacia Street)
- h) Sct. Limbaga Street (from Mother Ignacia Street towards 11th Jamboree Street)
- i) Sct. Limbaga Extention (from 11th Jamboree Street towards Sct. Fuentabella Extention)
- j) Sct. Rallos Street (from 11th Jamboree Street towards Mother Ignacia Street)
- k) Panay Street (from Sct. Reyes Street towards Street Magbanua Street)
- 2. The following streets are considered as two-way flow traffic street;
 - a) Sct. Gandia Street
 - b) Dr. Lazcano Street
 - c) Sct. Tobias Street in Barangay Laging Handa
 - d) Sct. Tuason Street in Barangay Laging Handa
 - e) Sct. Santiago Street in Barangay Laging Handa
 - f) Sct. Reyes Street in Barangay Paligsahan
 - g) Mother Ignacia Street in Barangay Laging Handa
 - h) Sct. Magbanua Street in Barangay Paligsahan
 - i) Panay Avenue (from Sct. Magbanua towards Roces Avenue and Timog Avenue up to Sct. Reyes Street) in Barangay Paligsahan /





- j) Sct. Torillo Street in Barangay Sacred Heart
- k) Sct. Ybardolaza Street in Barangay Sacred Heart
- l) 11th Jamboree Street in Barangay Sacred Heart

SECTION 3. ENFORCEMENT – This Ordinance shall be enforced and implemented by the Department of Public Order and Safety (DPOS) and by the Barangay Public Security Officer (BPSO) of Barangays Laging Handa, Paligsahan and Sacred Heart.

SECTION 4. INSTALLATION OF SIGNAGE TRAFFIC SCHEME – The Department of Public Order and Safety (DPOS) and Barangays Laging Handa, Paligsahan and Sacred Heart are hereby mandated to install a Traffic Signage indicating that the street is regulated, either as one-way or two-way in order to inform motorists, drivers, vehicle owners and the public in general.

SECTION 5. PENALTIES – Any person or persons found to be violating the provision/s of this Ordinance shall be penalized in accordance with Appendix VI of Ordinance No. SP-1444, 2004, otherwise known as the Quezon City Traffic Management Code, as amended.

SECTION 6. SEPARABILITY CLAUSE – If, for any reason or reasons, any part or provision of this Ordinance is held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 7. REPEALING CLAUSE – All existing ordinances and resolutions, local executive orders, rules and regulations inconsistent with any of the provisions of this Ordinance are hereby repealed and/or modified accordingly.
