ORDINANCE NO. SP- **2537**, S-2016^{11th}

AN ORDINANCE MANDATING THE ESTABLISHMENT OF DRUG TESTING LABORATORIES IN THE QUEZON CITY GENERAL HOSPITAL, NOVALICHES DISTRICT HOSPITAL, QUEZON CITY HEALTH DEPARTMENT, AND THE QUEZON CITY DRUG TREATMENT AND REHABILITATION CENTER (TAHANAN), AND APPROPRIATING THE NECESSARY FUNDS FOR ITS OPERATION FOR THE YEAR 2017 WHICH SHALL BE INCLUDED IN THE ANNUAL BUDGET.



WHEREAS, to complement its existing efforts and program, the City Government is hereby proposing the establishment of a Drug Testing Laboratories at the Quezon City General Hospital, Novaliches District Hospital, Quezon City Health Department, and the Quezon City Drug Treatment and Rehabilitation Center (TAHANAN).

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED THAT: 


SECTION 1. It is hereby established a Drug Testing Laboratory in the Quezon City General Hospital, Novaliches District Hospital, Quezon City Health Department and the Quezon City Drug Treatment and Rehabilitation Center (TAHANAN) which will be responsible for all requirements for drug testing that will be required by the Quezon City Government.

SECTION 2. It is hereby appropriated an amount for its operation in the year 2017 and funds shall be included in the annual budget for each of the department concerned as follows:



SECTION 3. This ordinance shall take effect upon its approval.




