ORDINANCE NO. SP- **2543**, S-2016

AN ORDINANCE CREATING THE LOCAL PROJECT MANAGEMENT TEAM (LPMT), DEFINING ITS POWERS, COMPOSITION, DUTIES AND FUNCTIONS, PURSUANT TO THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) MEMORANDUM CIRCULAR (MC) NO. 2015-56 AND FOR OTHER PURPOSES.

WHEREAS, DILG Memorandum Circular (MC) No. 2015-56 establishes the guidelines for the implementation of DILG Micro-Medium-Rise Building (MMRB) projects by the Local Government Units (LGUs);

WHEREAS, by virtue of MC No. 2015-56, funds shall be allocated and transferred to LGUs to finance the construction of MMRB projects under the concept of People's Plan, which project beneficiaries are informal settler families living in dangerous areas in Metro Manila;

WHEREAS, the DILG has already downloaded to Quezon City Government (LGU-QC) two (2) separate funds; a Php100 Million Fund earmarked for the construction of the housing component of proposed socialized housing project in Kaingin Bukid, Barangay Apolonio Samson, Quezon City, and a Php94 Million Fund earmarked for the construction of the housing component of socialized housing project labeled as Bistekville-15, located in Barangay Sauyo, Quezon City;

WHEREAS, paragraph III.B.3 of MC No. 2015-56 requires LGU-QC to establish or commit to establish, through an ordinance, a Local Project Management team (LPMT) that will oversee the project implementation, composed among others, of at least 50% coming from proponent CSOs/Pos.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY
IN REGULAR SESSION ASSEMBLED:

SECTION 1. CREATION – Pursuant to DILG Memorandum Circular No. 2015-56, the Local Project Management Team of Quezon City is hereby created.


SECTION 2. COMPOSITION – The Local Project Management Team which shall hereinafter referred to as LPMT, shall be composed of the following:

Chairperson : The City Mayor
Vice-Chairman : The Chairman, SP Committee on Housing
Members : Representative from DILG –ISFPMO
 : Representative from DILG-Quezon City
 : Representative from PCUP
 : Representative from SHFC
 : Representative from Bgy. Council concerned
 : The Head, HCDRD
 : The President of concerned HOAs/ Pos
 : The Vice President of concerned HOAs/ Pos
 : The Secretary of concerned HOAs/ Pos
 : The Auditor of concerned HOAs/ Pos
 : The Chairperson of the Board of Directors

SECTION 3. POWERS AND FUNCTIONS – The LPMT shall be in-charge in the over-all monitoring of the implementation and development of the project/s. As such, there shall be a periodic monitoring and evaluation reports to be prepared and submitted to the Chairperson of LPMT and to the DILG.

SECTION 4. MEETING AND QUORUM – The LPMT shall meet at least once a month or as deemed necessary until the completion of the project. The presence of the Chairperson or his authorized representative and the majority of the members shall constitute a quorum to transact official business.


SECTION 5. REPEALING CLAUSE – All ordinances and other City issuances or any part or parts thereof which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly. ✕




SECTION 6. SEPARABILITY CLAUSE – Should any of the provision of this Ordinance be declared invalid, the validity of the other provisions thereof shall remain unaffected thereby.

SECTION 7. EFFECTIVITY – This Ordinance shall take effect upon its approval.




