ORDINANCE NO. SP- 2568 , S-2017

AN ORDINANCE PROVIDING FOR ADDITIONAL TERMS AND CONDITIONS IN CONNECTION WITH THE AUTHORITY GRANTED BY THE QUEZON CITY COUNCIL FOR THE ISSUANCE OF A SPECIAL USE PERMIT TO OPERATE TRANSPORT TERMINALS AND/OR GARAGES IN QUEZON CITY.

WHEREAS, the Quezon City Council, through Resolutions adopted for the purpose, authorized the issuance of Special Use Permits to transport companies to operate transport terminals and/or garage in Quezon City;

WHEREAS, Section 16 or the General Welfare Clause of the Local Government Code of 1991 provides, among others, that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Article 7, Section 2 (h) and 2 (i) of Quezon City Comprehensive Zoning Ordinance No. SP-918, S-2000, as amended by Ordinance No. SP-1369, S-2003, prescribes the terms and conditions in granting a special use permit to transport terminals and/or garages;


WHEREAS, in order to protect the interest, public safety and general welfare of the commuting public, there is a need to provide appropriate terms and conditions in the authority granted by the Quezon City Council for the issuance of Special Use Permits to transport companies to operate transport terminals and/or garage in Quezon City.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. All transport companies operating transport terminals and/or garage in Quezon City are hereby mandated to conform to the terms and conditions in connection with the authority granted by the Quezon City Council for the issuance of a Special Use Permit, in addition to the terms and conditions provided for in the Quezon City Comprehensive Zoning Ordinance, as follows:

- a. The Special Use Permit shall be automatically revoked in case the franchise to operate of the transport company is cancelled by the Land Transportation Franchising and Regulatory Board (LTFRB).
- b. Only public utility vehicles of the transport company shall use the transport terminal and/or the garage. The public utility vehicles shall have the appropriate body markings of the transport company.
- c. Transport companies shall not park any of its public utility vehicles outside or any streets within the vicinity of the terminal and/or garage.

- d. In case the transport company is sold, the new owner shall apply for a new special use permit to operate transport terminals and/or garage in the name of the new owner.
- e. The Special Use Permit to operate transport terminals and/or garage shall be automatically revoked in case the transport company ceases to operate.
- f. The City Council may revoke the authority for the issuance of a Special Use Permit to transport companies to operate transport terminals and/or garages in Quezon City in cases of habitual violations of traffic laws, rules and regulations committed by drivers of the transport company as recommended by the Metropolitan Manila Development Authority (MMDA), Quezon City Police District, Traffic Bureau and/or the Department of Public Order and Safety (DPOS).

SECTION 2. SCOPE – This ordinance shall cover all transport companies operating transport terminals and/or garages in Quezon City.

SECTION 3. SEPARABILITY CLAUSE. – If any portion or provision of this ordinance is declared unconstitutional, the same shall not affect the validity and effectivity of the rest of this ordinance.

SECTION 4. REPEALING CLAUSE – Ordinances, executive orders, rules and regulations, and other issuances of the city government, or parts thereof, inconsistent with this ordinance are hereby repealed or modified accordingly.

All Resolutions adopted by the Quezon City Council authorizing the granting of Special Use Permits for the operation of transport terminals and/or garage are hereby amended and/or modified accordingly and therefore subject to the foregoing terms and conditions.
