AN ORDINANCE AMENDING ORDINANCE NO. SP-2546, S-2016, ENTITLED, "AN ORDINANCE APPROVING SUPPLEMENTAL BUDGET NUMBER 1, GENERAL FUND FOR FISCAL YEAR 2016 IN THE AMOUNT OF TWO BILLION NINE HUNDRED FORTY FOUR MILLION THREE HUNDRED TWENTY EIGHT THOUSAND THREE HUNDRED EIGHTY NINE PESOS (PHP2,944,328,389.00) TO FUND VARIOUS MAINTENANCE AND PLANT EQUIPMENT EXPENDITURES AND PROCUREMENT AND FOR OTHER PURPOSES."




