NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Admission Fees in all cinemas/movie houses in Quezon City are hereby increased by One Peso (P1.00) for the period of November 1 to 30, 2017.

SECTION 2. All concerned movie/cinema owners and operators are hereby authorized to transmit and turn over to the Philippine Red Cross – Quezon City Chapter all sums of money collected, and the Philippine Red Cross – Quezon City Chapter will account for all such money received and submit to the City Treasurer of Quezon City, official receipts and such other pertinent records as maybe required in the acknowledgment thereof, subject to the usual accounting regulations. The City Treasurer is hereby directed to submit the corresponding report to the City Council in connection therewith.
