ORDINANCE NO. SP- **2650**, S-2017

AN ORDINANCE DECLARING MATAHIMIK STREET AND MANINGNING EXTENSION AS "ONE SIDE ALTERNATING PARKING" IN THE VICINITY OF BARANGAY MALAYA, DISTRICT IV, QUEZON CITY AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

WHEREAS, Section 458 (a)(5)(v) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the Sangguniang Panlungsod to enact ordinances to regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same;

WHEREAS, Section 458 (a)(5)(vi) of the same Code likewise empowers the Sangguniang Panlungsod to approve ordinances that regulate traffic on all streets and bridges, prohibit encroachments or obstacles thereon and when necessary in the interest of public welfare authorize the removal of encroachments and illegal constructions in public places;

WHEREAS, the Sangguniang Barangay of Baranghy Malaya, passed Resolution No. 027, S-17, entitled: *Y S S*

WHEREAS, double parking of vehicles on the said Streets has been our problem, specially residents and commercial establishments who are using the road as parking area. It delays garbage trucks that are passing along the thoroughfare and could possibly hamper emergency vehicles from responding to emergency situations in the barangay:

WHEREAS, in order to regulate the usage of parking and to avoid issues of bias or the perception of giving parking advantage to one to the disadvantage of another, the Council finds it proper to declare it as "ONE SIDE ALTERNATE PARKING" as described hereunder and declaring the opposite side as "NO PARKING AND TOW AWAY ZONE", under the following scheme:

- a. Allow parking along Matahimik Street, RIGHT SIDE from corner of Matino Street to dead end of Matahimik Street, Barangay Hall and allow parking along Maningning Extension RIGHT SIDE from corner of V. Luna Rd., Ext. to corner of Matahimik Street, from the 1st to the 15th day of every month;
- b. Allow parking along Matahimik Street, LEFT SIDE from corner of Matino Street to dead-end of Matahimik Street, Barangay Hall and allow parking along Maningning Extension LEFT SIDE from corner of V. Luna Rd. Ext., to corner of Matahimik St., from the 16th to the 31st day of the month;
- c. During Sundays, allow parking on both sides, for light vehicles and for residents only.
- d. For establishments, any huge vehicle like bulldozer, bus, container trucks for delivery is prohibited to stay for more than ten (10) minutes unless permitted by the Barangay.
- e. First come first served basis only. No reservation for parking.
- f. All unserviceable/junk vehicles shall be towed or removed to maximize the parking space.
- g. The opposite side of the allowable parking under the scheme described above shall be considered as "Tow Away Zone".
- h. Any vehicle is prohibited to park or block any driveway.

WHEREAS, violations of any of the following measures will be subject to the issuance of Ordinance Violation Receipt (OVR), under City Government or any authorized government agencies, for the towing of vehicles;

WHEREAS, it is incumbent upon the City Government to regulate the traffic situation and road conditions within its jurisdiction, for the welfare and safety of its residents.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. TITLE - "AN ORDINANCE DECLARING MATAHIMIK STREET AND MANINGNING EXTENSION, AS "ONE SIDE ALTERNATING PARKING" IN THE VICINITY OF BARANGAY MALAYA, DISTRICT IV, QUEZON CITY AND PROVIDING PENALTIES FOR VIOLATION THEREOF."

SECTION 2. COVERAGE - The entire stretches of Matahimik Street and Maningning Extension, Barangay Malaya, District IV, Quezon City.


SECTION 3. ENFORCEMENT - This Ordinance shall be enforced and implemented by the Department of Public Order and Safety (DPOS) and by the Barangay Public Safety Officers (BPSO) of said Barangay.

The DPOS is likewise hereby mandated to install a "ONE SIDE ALTERNATING PARKING" sign.

SECTION 4. PENALTY - A penalty of One Thousand Five Hundred Pesos (Php1,500.00) shall be imposed on any person or persons found violating the provisions of this Ordinance.

SECTION 5. REPEALING CLAUSE - All ordinances, resolutions, local executive orders, rules and regulations, or any part thereof inconsistent herewith are deemed repealed, modified or amended accordingly.

SECTION 6. SEPARABILITY CLAUSE - In case any provision of this Ordinance is declared unconstitutional or invalid, the other provisions hereof which are not affected thereby shall remain in full force and effect. ✕



SECTION 7. EFFECTIVITY CLAUSE - This Ordinance shall take effect immediately upon its approval.




