ORDINANCE NO. SP- **2661** , S-2018

AN ORDINANCE ACCREDITING THE EIGHTY THREE (83) NON-GOVERNMENTAL ORGANIZATIONS (NGOs) AND PEOPLE'S ORGANIZATIONS (POs) PURSUANT TO THE PROVISIONS OF REPUBLIC ACT NO. 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991, AND ITS IMPLEMENTING RULES AND REGULATIONS, IN RELATION TO MEMORANDUM CIRCULAR NO. 2016-97 OF THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT.

WHEREAS, Section 34 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that local government units shall promote the establishment and operations of non-governmental organizations (NGOs) and people's organizations (POs) to become partners in the pursuit of local economy;

WHEREAS, Article 64 of the Implementing Rules and Regulations (IRR) of the said Code, provides that the local sanggunian concerned shall accredit the NGOs and POs based within its jurisdiction, subject to the criteria and procedures for membership set forth by the local special bodies; ¶
