ORDINANCE NO. SP- **2695** , S-2018

AN ORDINANCE AMENDING ORDINANCE NO. SP-2139, S-2012, OTHERWISE KNOWN AS "AN ORDINANCE MANDATING BUSINESS ESTABLISHMENTS OPERATING WITHIN THE TERRITORIAL JURISDICTION OF QUEZON CITY TO INSTALL CLOSED CIRCUIT TELEVISION SYSTEM (CCTV) AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF" PROVIDING FOR THIS PURPOSE, THE MINIMUM TECHNICAL STANDARDS AND SPECIFICATIONS AS PER DILG MEMORANDUM CIRCULAR NO. 2014-119.

WHEREAS, City Ordinance No. SP-2139, S-2012 was enacted to encourage the adoption and use of CCTV systems in business establishments within the territorial jurisdiction of Quezon City, and in order to intensify the City's effort to solve criminality, and to preserve visual footage as evidence;

WHEREAS, the Department of the Interior and Local Government (DILG), issued memorandum circular no. 2014-119 providing the minimum technical specifications to be required of CCTVs to be installed in certain business establishments in accordance with Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;
