**AN ORDINANCE FOR THE CONSTRUCTION OF THE STATUE/MONUMENT OF PRESIDENT MANUEL LUIS QUEZON WITHIN THE COMPOUND OF NOVALICHES DISTRICT CENTER (NDC), QUEZON CITY AND APPROPRIATING FUNDS FOR THE PURPOSE.**

*WHEREAS, President Manuel Luis Quezon, a lawyer, soldier and statesman, is the Father of Quezon City;*

*WHEREAS, years later, after signing the law creating Quezon City on October 12, 1939, President Quezon became instrumental in declaring Quezon City to be the then official capital of the Philippines and permanent seat of the national government where people live with pride and dignity;*

*WHEREAS, as a leader and one of the most illustrious sons of the country, President Quezon likewise spearheaded the city's growth and development which made Quezon City a premier locality in the metropolis;*

*WHEREAS, in recognition of his valuable contribution and remarkable achievements as the Quezon City's founder, it is but appropriate to establish his statue/monument within the compound of Novaliches District Center, the city's arm in extending quality service to the people of Novaliches.*

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:


SECTION 1. The construction of the statue/monument of President Manuel Luis Quezon within the compound of Novaliches District Center (NDC), Quezon City is hereby mandated.

SECTION 2. The Department of Engineering, in consultation with the Office of the City Mayor and the city's Department of Tourism, shall take charge in the implementation of this Ordinance.

SECTION 2. To carry the purpose of this Ordinance, the amount of One Million Five Hundred Pesos (Php1,500,000.00) or so much thereof, is hereby appropriated from any available funds of the City Treasury.

SECTION 3. This Ordinance shall take effect immediately upon its approval.


