AN ORDINANCE AMENDING ARTICLE VI, SECTION 1, ARTICLE X, SECTION 2, ARTICLE XX, SECTION 1(5), SECTIONS 3 AND 4 AND ADDITIONAL SECTION OF BOOK IV, BOOK V (Article I and III) OF ORDINANCE NO. SP-2337, S-2014, ENTITLED "AN ORDINANCE ADOPTING THE QUEZON CITY TRICYCLE MANAGEMENT CODE OF 2014."

WHEREAS, during the Legislative-Executive Development Advisory Council (LEDAC) held last 8th of August 2018, the City Mayor, Honorable Herbert M. Bautista, in one of his many visions for the City, has initiated the proposal for the modernization of mass transportation in Quezon City, particularly the Motorized Tricycles being used by the public for transportation along barangay roads and avenues;

WHEREAS, Section 458 (a)(3)(vi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", provides that subject to the guidelines prescribed by the Department of Transportation and Communications (currently Department of Transportation), the Sangguniang Panlungsod shall regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the city; †
