RESOLUTION NO. SP-188, S-93

A RESOLUTION RATIFYING THE DEED OF DONATION AND ACCEPTANCE EXECUTED IN QUEZON CITY ON JULY 16, 1993 BY AND BETWEEN THE QUEZON CITY GOVERNMENT, AS DONOR, REPRESENTED BY THE CITY MAYOR, HON. ISMAEL A. MATHAY, JR., AND THE NOH-SCHOOL FOR CRIPPLED CHILDREN, AS DONEE, REPRESENTED BY ITS TEACHERS-PERSONNEL ASSOCIATION'S PRESIDENT, MRS. MYRIAM P. BARRAMEDA, WHEREBY THE DONOR CEDED AND TRANSFERRED IN FAVOR OF THE DONEE ONE (1) HINO BUS, PLATE NO. SDJ-837 AND COVERED BY LTO CERTIFICATE OF REGISTRATION NO. 49570086; AND REVOCATION OF DEED OF DONATION EXECUTED BY THE QUEZON CITY GOVERNMENT, REPRESENTED BY ITS CITY MAYOR, HON. ISMAEL A. MATHAY, JR., WHEREBY THE QUEZON CITY GOVERNMENT REVOKED THE PREVIOUS DEED OF DONATION EXECUTED IN QUEZON CITY ON AUGUST 11, 1992 IN FAVOR OF NOH-SCHOOL FOR CRIPPLED CHILDREN, FOR THE DONATION OF ONE (1) HINO BUS, PLATE NO. SDJ-818 AND COVERED BY LTO CERTIFICATE OF REGISTRATION NO. 09176141.

WHEREAS, previously, on August 11, 1992, the Quezon City Government, thru a Deed of Donation and Acceptance, ceded and transferred in favor of NOH-School for Crippled Children one (1) Hino Bus with Plate No. SDJ-818 and covered by LTO Certificate of Registration No. 09176141, duly ratified by the Quezon City Council thru Resolution No. SP-30, S-92;

WHEREAS, the parties to the said Deed of Donation and Acceptance agreed to have the bus donated substituted with another that is in better running condition;


WHEREAS, on July 19, 1993, the same parties executed another Deed of Donation and Acceptance which formally effected the agreement to substitute, covering another Hino Bus, Plate No. SDJ-837 and covered by LTO Certificate of Registration No. 49570086;

WHEREAS, relative thereto the Quezon City Government revoked the first Deed of Donation and Acceptance;


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it does hereby ratify, the Deed of Donation and Acceptance executed in Quezon City on July 16, 1993 by and between the Quezon City Government, represented by the City Mayor, Hon. Ismael A. Mathay, Jr., as Donor, and the NOH-School for Crippled Children, represented by its Teachers-Personnel Association's President, Mrs. Myriam P. Barrameda, as Donee, whereby the Donor ceded and transferred in favor of the Donee one (1) Hino Bus, Plate No. SDJ-837 and covered by LTO Certificate of Registration No. 49570086, which document was entered in the Notarial Registry of Atty. Jose L. Pecson as Doc. No. 196, Page No. 41, Book No. XIV, Series of 1993; and the Revocation of Deed of Donation executed in Quezon City by the Quezon City Government, represented by the City Mayor, Hon. Ismael A. Mathay, Jr., whereby the City revokes, annuls and makes void the previous Deed of Donation and Acceptance in favor of NOH-School for Crippled Children for the donation of one (1) Hino Bus, Plate No. SDJ-818 and covered by LTO Certificate of Registration No. 09176141 which document was entered in the Notarial Registry of Atty. Engracio M. Icasiano, as Doc. No. 352, Page No. 71, Book No. VIII, Series of 1993, both documents are attached herewith and made integral part hereof.
