Mathay, Jr., to enter into a Deed of Donation with the Biyaya Corporation, represented by its President Mr. Paul Sycip, by accepting the Donation made by said corporation in favor of Quezon City, involving two (2) lots covered by TCT No. RT89083 and TCT No. RT89086, respectively, situated in Maligaya Park Subdivision, Barangay Pasong Putik, Novaliches, Quezon City.
