A RESOLUTION RATIFYING THE DEED OF DONATION ENTERED INTO BY AND BETWEEN THE DIAMOND LAND CORPORATION, AS DONOR, AND THE QUEZON CITY GOVERNMENT, THRU HONORABLE ISMAEL A. MATHAY, JR., CITY MAYOR OF QUEZON CITY, AS DONEE, INVOLVING TWENTY-TWO (22) PARCELS OF LAND (ROAD LOTS), WITH AN AGGREGATE AREA OF FIFTEEN THOUSAND FIVE HUNDRED TWO (15,502) SQUARE METERS, WHICH IS A PORTION OF DIAMOND VILLAGE AND THE SIERRA MADRE SUBDIVISIONS, LOCATED AT BARANGAY KALIGAYAHAN, NOVALICHES, QUEZON CITY.


WHEREAS, the ratification of said donation by the City Council of Quezon City will promote public welfare and serve the best interest of the residents of the City.
