RESOLUTION NO. SP- 636, S-96

A RESOLUTION URGING THE NATIONAL HOUSING AUTHORITY (NHA) TO DONATE TO THE QUEZON CITY GOVERNMENT A PARCEL OF LAND DESCRIBED AS ROAD LOT 46, PSD-56573, BEING A PORTION OF LOT 18, PCS-4546, WITH AN AREA OF TWO HUNDRED EIGHTY SQUARE METERS (280 SQ. M.) LOCATED AT MABAIT EXTENSION, BETWEEN MATAHIMIK STREET AND KALAYAAN AVENUE, BARANGAY TEACHERS VILLAGE WEST, QUEZON CITY, TO BE USED AS A PERMANENT SITE FOR A BARANGAY HALL OR AS A COMMUNITY ACTIVITY CENTER.

WHEREAS, Barangay Teachers Village West is in need of a permanent site for its proposed Barangay Hall which they shall determine as suitable;

WHEREAS, a certain Road Lot 46, Psd-56573, being a portion of Lot 18, Pcs-4546, with an area of two hundred eighty (280) square meters located at Mabait Extension, between Matahimik Street and Kalayaan Avenue, Barangay Teachers Village West, Quezon City, is the only available and practical site for the said Barangay Hall as described in Barangay Resolution No. 14, S-96 of the said Barangay;

WHEREAS, to date the National Housing Authority has not turned over the said property to the City government.
