RESOLUTION NO. SP- 649, S-96

A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO THE SEVENTY-EIGHT (78) FAMILIES WHO WERE VICTIMS OF FIRE AT AGHAM ROAD, BARANGAY CENTRAL, DISTRICT IV, QUEZON CITY, ON MAY 22, 1996, AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY-OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY-RENTER/SHARER AND ALLOCATING THE SUM OF ONE HUNDRED FIVE THOUSAND PESOS (P105,000.00) TO BE TAKEN FROM ANY AVAILABLE FUNDS OF THE CITY GOVERNMENT.

WHEREAS, the Quezon City Council has the power to enact ordinances that would protect the inhabitants of the City from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance to the victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events as provided for in Section 458 (a) (1) (iv) of the Local Government Code of 1991;

WHEREAS, on May 22, 1996, Barangay Central, Area 24, District IV, Quezon City, was hit by fire affecting seventy-eight (78) families, broken down as follows:

Family Owners	-	27
Family Renters	-	47
Family Sharers	-	<u>4</u>
Total		78

WHEREAS, because of this calamity, they are experiencing financial difficulties.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to extend, as it does hereby extend, financial assistance to the seventy-eight (78) families who were victims of the fire at Agham Road, Barangay Central, District IV, Quezon City, on May 22, 1996 in the amount of two thousand pesos (P2,000.00) per family-owner and one thousand pesos (P1,000.00) per family-renter/sharer and allocating the sum of one hundred five thousand pesos (P105,000.00) to be taken from any available funds of the City government.


RESOLVED, FURTHER, that the Social Services Development Department (SSDD) shall validate the list of fire victims and categorize them into family-owner, family-sharer and family-renter and coordinate for the early and/or immediate release of the herein assistance to qualified recipients as authenticated by the SSDD.

RESOLVED, FURTHERMORE, that the Office of the City Mayor shall confirm and revalidate the listing made by the Social Services Development Department before the payroll is finalized and that the amount hereby allocated shall be immediately released.
