RESOLUTION NO. SP- 650, S-96

A RESOLUTION AUTHORIZING THE HONORABLE ISMAEL A. MATHAY, JR., MAYOR OF QUEZON CITY, TO NEGOTIATE AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE METROPOLITAN WATERWORKS & SEWERAGE SYSTEM FOR THE DEVELOPMENT AND BEAUTIFICATION OF THE LA MESA DAM IN BARANGAY PASONG PUTIK, NOVALICHES, QUEZON CITY, AS A TOURIST SPOT AND PLACE FOR RELAXATION.

WHEREAS, the burgeoning population of Metro Manila demands close-to-nature places for relaxation that are accessible at minimal cost to them;

WHEREAS, the La Mesa Dam in Barangay Pasong Putik, Novaliches, Quezon City, is one of the few places hereabouts which are just about removed from the humdrum of the metropolis, which is ideal for development as a tourist attraction and place for wholesome relaxation;

WHEREAS, the project can be a self-sustaining enterprise as its minimal maintenance cost could be met by admission and rental fees;

WHEREAS, to accomplish the project, a Memorandum of Agreement should be forged between the Quezon City government as developer, and the Metropolitan Waterworks & Sewerage System as owner of the La Mesa Dam.



NOW, THEREFORE,
