RESOLUTION NO. SP- 657, S-96

A RESOLUTION AUTHORIZING THE GRANT OF FINANCIAL ASSISTANCE OF FORTY-SIX THOUSAND PESOS (P46,000.00) TO THE TWENTY SEVEN (27) FAMILIES WHO WERE VICTIMS OF FIRE THAT OCCURED ON DECEMBER 11, 1996 AT PARKLANE ST., GSIS VILLAGE, BGY., SANGANDAAN, QUEZON CITY, AT TWO THOUSAND PESOS (2,000.00) AND ONE THOUSAND PESOS (P1,000.00) PER HOUSEOWNER AND HOUSE RENTER/SHARER, RESPECTIVELY, THE AMOUNT TO BE CHARGED AGAINST THE APPROPRIATIONS FOR GRANTS, AIDS AND SUBSIDIES UNDER THE OFFICE OF THE CITY MAYOR IN THE 1996 ANNUAL BUDGET OF QUEZON CITY OR FROM ANY AVAILABLE FUNDS OF THE CITY GOVERNMENT.

WHEREAS, on December 11, 1996 a fire occurred at Parklane St., GSIS Village, Bgy. Sangandaan, Quezon City, which destroyed the houses and belongings of twenty seven (27) families, nineteen (19) of them are houseowners and eight (8) of them are house renters/sharers;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the grant of



financial assistance of Forty-six Thousand Pesos (P46,000.00) to the twenty seven (27) families who were victims of a fire that occurred on December 12, 1996 at Parklane St., GSIS Village Bgy. Sangandaan, Quezon City, at Two Thousand Pesos (P2,000.00) and One Thousand Pesos (P1,000.00), per houseowner and house renter/sharer, respectively, the amount to be charged against the appropriation for Grants, Aids and Subsidies under the Office of the City Mayor in the 1996 Annual Budget of Quezon City or from any available funds of the City government.
