RESOLUTION NO. SP- 688, S-97

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE ONE HUNDRED NINETY-EIGHT (198) FAMILIES WHO WERE VICTIMS OF A FIRE THAT OCCURED ON MARCH 27, 1997 AT MENDEZ ROAD, NPC, BARANGAY BAESA, QUEZON CITY, AT TWO THOUSAND PESOS (P2,000.00) PER HOUSEOWNER AND ONE THOUSAND PESOS (P1,000.00) PER HOUSE RENTER/SHARER, IN THE TOTAL AMOUNT OF THREE HUNDRED FIVE THOUSAND PESOS (P305,000.00) TO BE TAKEN FROM THE CALAMITY FUND OR FROM ANY AVAILABLE FUNDS OF THE CITY GOVERNMENT.




WHEREAS, at about 8:00 P.M., of March 27, 1997, several houses were razed by a fire that occurred at a depressed area in Mendez Road, NPC, Bgy. Baesa, Quezon City, which, as per report of the Social Services Development Department (SSDD), affected one hundred ninety-eight (198) families, one hundred seven (107) of which are houseowners, while 55 are house renters and 36 are sharers;

WHEREAS, under Section 458 (a) (1) (iv) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", the City Council has the power to:



"(iv) Adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said events";


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to the one hundred ninety-eight (198) families who were victims of a fire that occurred on March 27, 1997 at Mendez Road, NPC, Barangay Baesa, Quezon City, at Two Thousand Pesos (P2,000.00) per houseowner and One Thousand Pesos (P1,000.00) per house renter/sharer, in the total amount of Three Hundred Five Thousand Pesos (P305,000.00) to be taken from the calamity fund or from any available funds of the city government.
