RESOLUTION NO. SP- 693, S-97

A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO THE ONE HUNDRED FIFTY (150) FAMILIES WHO WERE RENDERED HOMELESS BY A FIRE AT ZAMBALES STREET, BARANGAY SAN MARTIN DE PORRES, CUBAO, DISTRICT IV, QUEZON CITY ON MARCH 26, 1997, IN THE AMOUNT OF TWO THOUSAND PESOS (P2,000.00) PER HOUSE-OWNER AND ONE THOUSAND PESOS (P1,000.00) PER HOUSE-RENTER/SHARER AND ALLOCATING THE SUM OF TWO HUNDRED TWENTY-EIGHT THOUSAND PESOS (P228,000.00) TO BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.



Introduced by Councilors NANETTE CASTELO DAZA, JOSEPH PETER S. SISON, RAMON G. MATHAY, BAYANI V. HIPOL and ALFREDO A. FRANCISCO (Fred Montilla).

WHEREAS, the Quezon City Council is empowered under Section 458 (a) (1) (iv) of R.A. 7160, otherwise known as the Local Government Code of 1991, to "adopt measures to protect the inhabitants of the City from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.";

WHEREAS, on March 26, 1997, Zambales Street, Barangay San Martin De Porres, District IV, Quezon City, was hit by fire rendering homeless, as per census by the Social Services Development Department, one hundred fifty (150) families categorized, as follows:

Family Owners	Seventy Eight	(78)
Family Renters	Thirty Nine	(39)
Family Sharers	Thirty Three	(33)
Total	One Hundred Fifty	(150)

WHEREAS, because of this unfortunate incident, our constituents, who are presently found in makeshift dwellings can only hope for and pray for the early release of financial assistance from the City government;

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to extend, as it does hereby extend, financial assistance to the one hundred fifty (150) families who were affected by the fire at Zambales Street, Barangay San Martin De Porres, District IV, Quezon City, in the amount of Two Thousand Pesos (P2,000.00) per house-owner and One Thousand Pesos (P1,000.00) per house-renter/sharer, and allocating the sum of Two Hundred Twenty Eight Thousand Pesos (P228,000.00) to be taken from the Calamity or Emergency Fund of the City government or from any available funds in the City Treasury.


RESOLVED, FURTHER, that the Social Services Development Department shall validate and authenticate the list of fire victims categorized into house-owner, house-renter and house-sharer, submit the same to the Office of the City Mayor and make representation for the early release of the financial assistance to the qualified recipients.

RESOLVED, FINALLY, that the Office of the City Mayor shall re-validate and confirm the list submitted by the Social Services Development Department which will be the basis for the preparation of the payroll and approval of the immediate release of funds allocated for the purpose.
