RESOLUTION NO. SP- 918 S-98

A RESOLUTION AUTHORIZING THE HON. ISMAEL A. MATHAY, JR., MAYOR OF QUEZON CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT ON BEHALF OF THE QUEZON CITY GOVERNMENT WITH THE GROUP 2 NEIGHBORHOOD ASSOCIATION (2.7 HAS.) INC., THE DOWAL REALTY AND MANAGEMENT SYSTEMS, INC., AND THE MILROSE REALTY DEVELOPMENT CORPORATION, TO ENABLE THE MEMBERS OF SAID ASSOCIATION TO PURCHASE THE LOTS THEY PRESENTLY OCCUPY UNDER THE TERMS AND CONDITIONS SET FORTH IN THE PROPOSED MEMORANDUM OF AGREEMENT.


