RESOLUTION NO. SP- 925, S-98

A RESOLUTION AUTHORIZING THE HONORABLE ISMAEL A. MATHAY, JR., MAYOR OF QUEZON CITY, TO ENTER INTO A CONTRACT OF SALE WITH GLORIA FRANCO REYES, FOR THE PURCHASE OF A STRIP OF LAND MEASURING TWO (2) METERS WHICH, IS A PORTION OF THAT PARCEL OF LAND COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 15472 ISSUED IN HER NAME, SITUATED IN DOÑA ROSARIO SUBDIVISION, BARANGAY NOVALICHES PROPER, QUEZON CITY.

WHEREAS, the one hundred fifty or so families residing in the Santos, Ramirez, and de Jesus Compounds, Doña Rosario Subdivision, Barangay Novaliches Proper, Quezon City, had for a long time, been using a strip of land measuring two (2) meters by twenty-three (23) meters which is a portion of that parcel of land covered by Transfer Certificate of Title No. 15472 in the name of Gloria Franco Reyes, as service pathwalk leading to a footbridge constructed by Brgy. Novaliches Proper;

WHEREAS, the Santos Compound Neighborhood Association, in its Resolution No. 2, S-98, requested the Honorable City Mayor of Quezon City to purchase the afore-mentioned strip of land for their road right-of-way;

WHEREAS, the Barangay Council of Novaliches Proper, in its Resolution No. 18, S-98, likewise requested the Honorable Ismael A. Mathay, Jr., to acquire the same piece of land mentioned above, also for the use of the residents as road right-of-way;

Mathay, Jr., to enter into a Contract of Sale with Gloria Franco Reyes, for the purchase of a strip of land measuring two (2) meters by twenty-three (23) meters, or forty-six (46) square meters, which is a portion of that parcel of land covered by Transfer Certificate of Title No. 15472 issued in her name, situated in Doña Rosario Subdivision, Barangay Novaliches Proper, Novaliches, Quezon City.
