RESOLUTION NO. SP- 928 - 1 S-98

A RESOLUTION GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO THE FAMILY OF THE LATE JAIME S. BARBACHANO, A FORMER POLICE AUXILLIARY, DEPARTMENT OF PUBLIC ORDER AND SAFETY, QUEZON CITY, THE AMOUNT TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE 1998 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS THEREOF.

WHEREAS, Jaime S. Barbachano died of a heart attack on February 26, 1998 while directing traffic along Sauyo Road, Novaliches, Quezon City;

WHEREAS, Jaime S. Barbachano has already been in the government service for five (5) years at the time of his death;


WHEREAS, having died due to job-related ailment incurred in line of duty, Jaime S. Barbachano deserves to be extended financial assistance to lighten the burden of his bereaved widow and two children occasioned by his untimely death;


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance in the amount of Thirty Thousand Pesos (P30,000.00) to the family of the late Jaime S. Barbachano, a former Police Auxilliary, Department of Public Order and Safety, Quezon City, the amount to be charged against the appropriation for grants, subsidies, and contributions in the 1998 annual budget of the City Mayor or from any available funds thereof.
