RESOLUTION NO. SP- **9310** , §-98

A RESOLUTION RATIFYING THE SECURITY SERVICE CONTRACT BETWEEN THE QUEZON CITY GOVERNMENT, REPRESENTED BY THE HONORABLE ISMAEL A. MATHAY, JR., MAYOR OF QUEZON CITY, AND THE PHILAND SECURITY AND DETECTIVE AGENCY, INC., REPRESENTED BY FELICITO A. VALMOCINA, GENERAL MANAGER, COVERING THE PERIOD FEBRUARY 15, 1998 TO FEBRUARY 15, 1999, SUBJECT TO EXISTING LAWS, RULES, AND ORDINANCES.

WHEREAS, the Quezon City Government has engaged the services of the Philand Security and Detective Agency for the purpose of guarding and protecting Quezon City Government premises, namely the engineering motorpool, Polytechnic, General Hospital, and the Amoranto Stadium from theft, pilferages, burglary, robbery, arson, vandalism, trespass, detainer and other unlawful acts per copy of the service contract hereto attached;

WHEREAS, The Philand Security and Detective Agency, has previously rendered the Quezon City Government the same service with satisfactory record; and that the present contract is but a renewal of the security service agreement between them which expired last February 14, 1998;


NOW, THEREFORE,

Valmocina, General Manager, covering the period February 15, 1998 to February 15, 1999, subject to existing laws, rules, and ordinances.
