RESOLUTION NO. SP- 937 - 98

A RESOLUTION GRANTING EXEMPTION FROM THE PAYMENT OF AMUSEMENT TAX ALL FILMS SHOWN AS PART OF THE PHILIPPINE CENTENNIAL FILM FESTIVAL (PCFF) DUBBED "KASAYSAYAN AT PELIKULA" FROM JUNE 17 TO 19, 1998 AT SM NORTH EDSA.

Introduced by Councilors GODOFREDO T. LIBAN II, EMILIO G. TAMAYO, ALBERTO M. GALARPE, MARCIANO P. MEDALLA, ANTONIO L. SIOSON, WILMA AMORANTO-SARINO, WINSTON "Wimmie" T. CASTELO, MICHAEL F. PLANAS, NANETTE CASTELO DAZA, HERMINIA C. ALTUNA and ALMARIO E. FRANCISCO.

WHEREAS, as a feature in the Philippine Centennial Celebration, the Philippine Centennial Commission (PCC), the Presidential Management Staff (PMS), and the Movie and Television Review and Classification Board (MTRCB), with the cooperation of the film industry, are sponsoring the Philippine Centennial Film Festival (PCFF) (Kasaysayan at Pelikula) from June 17-19, 1998;

WHEREAS, the theaters in SM North EDSA, Quezon City, will be the venue of the filmfest where the best in local cinematic work will be shown;

WHEREAS, MTRCB and filmfest Chairman Jesus C. Sison in a letter to His Honor, Mayor Ismael A. Mathay, Jr., has requested an exemption from the payment of the amusement tax all film participants in the PCF Festival at the SM North Edsa from June 17 to 19, 1998;

WHEREAS, the film participants were chosen for their historical and cultural value aside from their cinematic quality, and supporting them would be a positive move towards the attainment of the objectives of the Centennial Celebration;


NOW, THEREFORE,
