RESOLUTION NO. SP- 939 JS-98

A RESOLUTION GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO THE FAMILY OF THE LATE PO3 MARIANO V. RANJO, FORMER MEMBER OF THE CENTRAL POLICE DISTRICT COMMAND (CPDC), PHILIPPINE NATIONAL POLICE (PNP), THE AMOUNT TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE 1998 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS THEREOF.

WHEREAS, PO3 Mariano V. Ranjo, was a former member of the Central Police District Command (CPDC), Philippine National Police (PNP);

WHEREAS, in the light of the foregoing and in recognition of the services he had unselfishly and selflessly dedicated to the public; PO3 Mariano V. Ranjo deserves to be extended financial assistance to lighten the burden of his bereaved family occasioned by his untimely death;

WHEREAS, pursuant to Section 3 of Quezon City Ordinance No. SP-154, S-94, members of the Central Police District Command (CPDC) who die or suffer from total and permanent disability or incapacity in line of duty, regardless of length of police service are entitled to financial assistance by way of additional death or disability benefit in the amount of Thirty Thousand Pesos (P30,000.00);


NOW, THEREFORE,
