RESOLUTION NO. SP- 950 S-98

A RESOLUTION URGING THE HONORABLE CITY MAYOR TO ALLOCATE THE AMOUNT OF FIVE HUNDRED TWENTY THOUSAND PESOS (P520,000.00) FROM ANY AVAILABLE FUNDS IN THE CITY BUDGET FOR 1998 AS FINANCIAL ASSISTANCE TO THE FAMILIES OF THE VICTIMS OF THE LUNG CENTER OF THE PHILIPPINES' FIRE ON MAY 17, 1998.

WHEREAS, the tragic fire that hit the Lung Center of the Philippines in Quezon City immediately claimed the lives of twenty six (26) patients as a direct result of the tragedy, with sixty-one (61) others suffering from various ailments as a direct and indirect result of the fire, distributed to various hospitals;

WHEREAS, this incident constitutes one of the gravest tragedies that happened in Quezon city, casting a gloom upon the City;

WHEREAS, the grant of financial assistance to the families of the deceased victims would, to some extent, alleviate the agony of their loss and make the financial burden attending the loss more bearable;


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Honorable City Mayor to allocate the amount of Five Hundred Twenty Thousand Pesos (P520,000.00) from any available funds in the City Budget for 1998, as financial assistance to the families of victims of the Lung Center of the Philippines' fire on May 17, 1998.
