RESOLUTION NO. SP- 953, S-98

A RESOLUTION AUTHORIZING THE QUEZON CITY GENERAL HOSPITAL TO USE TWELVE MILLION PESOS (P12M) OF ITS HOSPITAL DEVELOPMENT FUND AND TO WITHDRAW SUCH AMOUNT FROM ITS TIME DEPOSITS TO PURCHASE AN 800-MA X-RAY MACHINE, AND ITS ACCESSORIES, AN AUTOCLAVE AND OTHER HOSPITAL EQUIPMENT, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, the Quezon City General Hospital (QCGH) is the only 250-bed capacity tertiary, general local government hospital of Quezon City serving the health care needs of the urban poor of the City;

WHEREAS, during the recent hospital inspection by the Unified Licensing Team of the Department of Health, one of the major deficiencies noted was the lack of an 800-MA x-ray machine and its accessories, an autoclave and other hospital equipment, which are mandatory requirements for the issuance of a license to operate a tertiary level hospital;

WHEREAS, the Quezon City government has approved the 1998 Executive Budget, but did not include enough funds for capital outlay for the QCGH for the purchase of an 800-MA x-ray machine and its accessories, an autoclave and other hospital equipment;

WHEREAS, the Quezon City General Hospital has accumulated the amount of Twelve Million Pesos (P12M) from donations and payment of hospital fees in the Hospital Development Fund which can be used to buy the required 800-MA x-ray machine and its accessories, an autoclave and other hospital equipment;

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Quezon City General Hospital to use Twelve Million Pesos (P12M) of its Hospital Development Fund and to withdraw such amount from its time deposits to purchase an 800-MA x-ray machine, and its accessories, an autoclave and other hospital equipment, subject to existing laws, rules and regulations.
