RESOLUTION NO. SP- 9 5 4 -S-98

A RESOLUTION AUTHORIZING THE HONORABLE ISMAEL A. MATHAY, JR., CITY MAYOR, QUEZON CITY, TO SELL TO THE HONORABLE JOSEPH PETER S. SISON, WHO RESIGNED AS CITY COUNCILOR OF QUEZON CITY ON MARCH 28, 1998, THE ASSIGNED MOTOR VEHICLE PARTICULARLY IDENTIFIED AS TOYOTA TAMARAW FX WITH PLATE NO. SEA-930 TOGETHER WITH THE OFFICE FURNITURE WHICH HE OFFICIALLY USED DURING HIS INCUMBENCY AS CITY COUNCILOR AT A PRICE TO BE DETERMINED BY THE CITY APPRAISAL COMMITTEE, SUBJECT TO EXISTING AUDITING RULES AND REGULATIONS.

WHEREAS, all City Councilors have been issued motor vehicles and office furniture by the Quezon City government for their official use in connection with the exercise of their official functions;

WHEREAS, the Honorable Joseph Peter S. Sison, who was formerly a City Councilor for two (2) terms and First Assistant Majority Floor Leader of the City Council had served well the constituents of the City for six (6) years;

WHEREAS, the motor vehicle and office furniture assigned to Councilor Joseph Peter S. Sison, former First Assistant Majority Floor Leader, are hereby described as follows:



Mathay, Jr., City Mayor, Quezon City, to sell to the former City Councilor Honorable Joseph Peter S. Sison, the assigned motor vehicle particularly identified as Toyota Tamaraw FX with Plate No. SEA-930 together with office furniture which he officially used during his incumbency as City Councilor, described herein above at a price to be determined by the City Appraisal Committee, subject to existing auditing rules and regulations.
