RESOLUTION NO. SP- 955 , §-98

A RESOLUTION AUTHORIZING THE HONORABLE ISMAEL A. MATHAY, JR., CITY MAYOR, QUEZON CITY, TO SELL TO HONORABLE ALBERTO M. GALARPE, AN INCUMBENT CITY COUNCILOR OF QUEZON CITY WHOSE FINAL TERM WILL END ON JUNE 30, 1998, THE ASSIGNED MOTOR VEHICLE PARTICULARLY DESCRIBED AS TOYOTA TAMARAW FX WITH PLATE NO. SED 443 TOGETHER WITH OFFICE FURNITURE USED BY HIM OFFICIALLY AT A PRICE TO BE DETERMINED BY THE CITY APPRAISAL COMMITTEE, SUBJECT TO EXISTING AUDITING RULES AND REGULATIONS.

WHEREAS, all City Councilors have been issued motor vehicles and office furniture by the Quezon City government for their official use or to be used in connection with the exercise of their official duties;

WHEREAS, Quezon City Council Resolution No. 8630, S-71, authorizes the sale to incumbent officials, officers and employees of the Quezon City government of vehicles and other office furniture presently assigned to them, should they be willing to purchase the same at their appraised value at the time of the sale; Provided, that taxes payable and due the government shall be shouldered by the purchaser;

WHEREAS, to sell the assigned motor vehicle and office furniture to the incumbent City Official who has been using the same during his term as City Councilor would be beneficial and advantageous to the Quezon City government considering the amount to be recovered out of the funds used in acquiring the vehicle and office furniture;


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Ismael A. Mathay, Jr., City Mayor, Quezon City, to sell to Honorable Alberto M. Galarpe, an incumbent City Councilor of Quezon City whose final term will end on June 30, 1998, the assigned motor vehicle particularly described as Toyota Tamaraw FX with plate no. SED 443 together with office furniture used by him officially and described hereinabove at a price to be determined by the City Appraisal Committee, subject to existing auditing rules and regulations.
