RESOLUTION NO. SP- 9 8 8 - 98

A RESOLUTION AUTHORIZING THE HONORABLE ISMAEL A. MATHAY, JR., CITY MAYOR, QUEZON CITY, TO SELL TO THE HONORABLE HERBERT M. BAUTISTA WHO RESIGNED AS CITY VICE MAYOR OF QUEZON CITY ON MARCH 27, 1998, THE ASSIGNED MOTOR VEHICLE PARTICULARLY IDENTIFIED AS ANFRA 140G TRANSPORTER WITH PLATE NO. SEU-632, TOGETHER WITH THE OFFICE EQUIPMENT WHICH HE OFFICIALLY USED DURING HIS INCUMBENCY AS CITY VICE MAYOR AT A PRICE TO BE DETERMINED BY THE CITY APPRAISAL COMMITTEE, SUBJECT TO EXISTING AUDITING RULES AND REGULATIONS.

WHEREAS, all City Councilors and the Vice Mayor have been issued motor vehicle and office equipment by the Quezon City government for their official use in connection with the exercise of their official functions;

WHEREAS, the Honorable Herbert M. Bautista who was formerly a KB Chairman, of Barangay Immaculate Conception, Federation President, City Councilor and City Vice Mayor had served well the constituents of Quezon City for Thirteen (13) years;]

WHEREAS, the motor vehicle and office equipment assigned to former Vice Mayor Herbert M. Bautista, are hereby described as follows:



BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Ismael A. Mathay, Jr., City Mayor, Quezon City to sell to the former City Vice Mayor Honorable Herbert M. Bautista, the assigned motor vehicle particularly identified as Anfra 14OG Transporter with Plate No. SEU-632 and office equipment which he officially used during his incumbency as City Vice Mayor described herein above, at a price to be determined by the City Appraisal Committee, subject to existing auditing rules and regulations.
